Yearly Dues Collection Nearing Completion

The Board of Trustees of the Victoria Park Homeowners' Association would like to express their thanks to the overwhelming majority of Victoria Park homeowners who have submitted their dues of \$100 for the current year. As of mid-May, payments have been received from over 95% of homeowners.

For those few homeowners that are delinquent in their dues (VP covenants state that dues are to be submitted by January 1st each year), the Board is obligated to file liens against their properties.

Clearing the lien is very expensive for the delinquent homeowner. Currently, the total lien includes the basic dues (\$100), a 6% per year interest charge (as established by the covenants), a lien recording fee (\$68), and finally attorney fees for filing and then clearing the lien (\$270). Thankfully, the Board has not had to exercise the lien process frequently.

Matching Grant

Received by Victoria Park

A resident within Victoria Park who wishes to remain anonymous has graciously provided a grant to the Victoria Park Homeowners' Association that is to be used towards renovation of the Children's Park.

The grant will reimburse two dollars to the association for every three dollars of total expenditure on new equipment, or on the renovation of existing equipment. The grant may be used to purchase or renovate benches, tables, or playground equipment, up to a maximum of **\$5,000** reimbursement.

Terms of the grant include the restrictions that the grant money is not to be used for routine maintenance such as painting and wood chip replenishment, and the grant money must be spent no later than October 1, 2008. The Victoria Park Board of Trustees wishes to gratefully thank the anonymous donor for this wonderful offer.

Children's Park Work Party

On April 29th Children's Park committee Co-Chairs Robert Rantucci and Lief Zimmerman organized a work party to perform some much needed maintenance on the grounds of the Park. Many blackberries were removed and the benches and picnic table were repaired and re-painted. Thank you to the neighbors for supplying water and power for the efforts.

You may also have noticed that the merry-go-round was dissembled. At some point in early spring the merry-go-round developed a dangerous tilt, and after disassembly it was found that two of the main support bolts had sheared off at ground level.

The Board has not yet found a reputable company that is willing to perform the necessary repairs, and the board is also reluctant to accept volunteer labor because of liability concerns. Other options, including replacement of the merry-go-round with a different piece of equipment, are being considered. So for now, the merry-go-round remains disabled.

Thanks to the generous Victoria Park resident (see *Matching Grant Received by Victoria Park* on opposite page) the Children's Park committee has many options to investigate. You will begin seeing upgrades in the Children's Park this summer.
